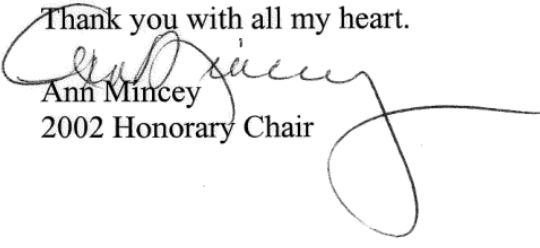
Dear Lori:

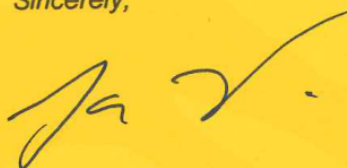
